Agenda Point- 1: Welcome speech by the chairperson

Resolution: The chairman of BoS, Mr.S. Murali Krishna, welcomed internal and external BOS members.

Agenda Point- 2: Introduction of members of the Board of Studies (BoS)

Resolution: The Chairman of BoS, Mr. S. Murali Krishna welcomed all the members and introduced internal BoS members to external BoS members. The meeting began with the presentation of B.Tech curriculum for semesters I & II.

Agenda Point-3: To discuss and finalize the proposed I B. Tech. I & II Semester CE courses of BR24 Regulations.

Resolution: After clearly discussing every unit of theory courses namely, Basic Civil & Mechanical Engineering (BCME) the university nominee and all the other BoS members opined to modify the syllabus of the proposed I B. Tech. I & II Semester courses of BR24 Regulations. Accordingly, as per the modifications, BoS has approved the syllabus for new regulations (BR24), and the details are mentioned in Annexure-A (Enclosed Annexure-A).

- For Basic Civil & Mechanical Engineering (BCME) course, there are six units, Topics of Three units from Civil Engineering and topics of three units are from Mechanical Engineering. The university nominee and other BoS members suggested to compress Six units into Five units.
- As per the suggestions by the members changes are made in Unit-I. Two units are merged into one. Half of the content in unit -I related to Civil engineering and half of content related to Mechanical engineering.
- Unit-II & III related to Civil Engineering and Unit-IV & V related to Mechanical Engineering is finalized.

Agenda Point- 4: Ratification of Course Objectives and Course Outcomes for the proposed subjects.

Resolution: After thorough discussion, the BoS approved the course objectives and course outcomes for the proposed courses based on the modifications made to the theory and labs as discussed in agenda point -3.

Agenda Point- 5: Finalization of Model Paper and List of Paper Setters

Resolution: The BoS members suggested to properly mention the COs in order as per the given questions of KL(Knowledge Level).The same has been done accordingly, verified the Course Objectives (COs) , Blooms Taxonomy levels and marks distribution in the proposed model Question papers for external examinations of theory courses and ratified.
