**Agenda Point-3:** To discuss and finalize the proposed UG- B. Tech-II & III year CSE, CSE (AI&ML) and PG- M.Tech- I & II year CSE (AI&ML) & M.Tech II year CSE - I & II Semester Course structures and syllabus of BR -24 Regulations.

**Resolution:** After clearly discussing every unit of theory subjects and Experiments of laboratory in B.
